## The Regime's Repressive Security Agencies Arrest a Group of Shabab from Hizb ut Tahrir

The regime's repressive security agencies arrested a group of Shabab of Hizb ut Tahrir namely: Mahmoud Mumtaz, Eng. Yousef Abu Eid, his son Ahmed Abu Eid, and Mohammed Abu al-Asal, after they carried out the activities of the campaign entitled: **«وَمَنْ أَحْسَنُ قَوْلًا مِّمَّن دَعَا إِلَى اللَّهِ وَعَمِلَ صَالِحًا وَقَالَ إِنَّنِي مِنَ الْمُسْلِمِينَ»** **“And who is better in speech than one who invites to Allah and does righteousness and says, "Indeed, I am of the Muslims.”** launched by Hizb ut Tahrir / Wilayah Jordan to invite and bring awareness to people of the need to arbitrate Allah's Shariah Law in all their affairs and situations, at a time the state governs the people by man-made legislation and turns away from the legislation of the Lord of mankind.
