By Saying, "We Sacrificed in the Unity of Sudan, and Lost the Unity and Peace"!

President Al-Bashir Finally Admits what Hizb ut Tahrir said, When Ears were silenced from hearing!

(Translated)

In a <u>televised interview</u> with President al-Bashir with CNBC channel at the sidelines of the African Union Summit in Kigali, in which Al-Bashir stated: "My government has signed the Comprehensive Peace Agreement (CPA) to end the war in our united country, and to end the suffering of people and displacement." He also said: "Unfortunately when the separation of the South happened, we lost our unity, but moreover we lost the most important thing, which is peace and security for our citizens living in the Southern part of Sudan."

In the face of this explicit recognition and confirmation of President al-Bashir of the gravity of that agreement on security and peace in the two parts of Sudan; north and south, we would like to remind the Ummah of the following facts:

Firstly, we in Hizb ut Tahrir Wilayah Sudan, have always warned President al-Bashir and his government, of the gravity of this fateful separation, which was sponsored by America, drew its map, and imposed it on the warring parties, but the government did not learn the lesson, blocked its ears, and responded to the plots of the Kaffir Western colonizer, who covets the country's wealth, until the heinous offense took place, and the South crippled and separated while suffering the brunt of war!

Secondly, Hizb ut Tahrir Wilayah Sudan has exposed the plans of dividing Sudan, holding substantial activities, including the distribution of hundreds of thousands of leaflets, in markets, mosques and public places, and issued press releases to various media outlets and journalists. The Hizb also held protests, established seminars in public squares, and in large halls, and rallied to the General Headquarters, prompting the motivated spirits in the sincere people of the armed forces. Marches also took place around the capital in its three cities, rejecting the secession of the South before it happened, and raising awareness to the people of the Ummah of the danger of the secession of the South. The Hizb also protested in front of the Parliament, and sent open letters to people of concern in the country, warning them of the plan of the fragmentation of Sudan. The party did not leave space for any excuse whether for the government or the opposition, politicians, the media, and the general public, the party has addressed all the people of Sudan to work on the rejection of this agreement, which led to the secession later, because of

its harm to the people and harm to the country, but the government insisted on implementing this scheme which no previous government ever implemented!

<u>Thirdly</u>, President al-Bashir, who regrets the secession of the South, instead of accepting the advice of Hizb ut Tahrir and its exposing the scheme of tearing Sudan which began with the separation of the South, by listening to the advice and focusing on thwarting the scheme, he sent his security forces to arrest the members of the Hizb, chasing them and bringing them to trial, as well as arbitrary arrests, called for questioning, harassing them, to cover for their crime of splitting the South, and to silence the truth. He also arrested our members from within the parliament while they were delivering an open letter to the MPs, warning them of the acceptance or implementation of the ominous Naivasha agreement!

Finally, regret without action is useless, and the opportunity is still there to rectify this error, and as long as President al-Bashir realized what Hizb ut Tahrir was saying and warning against, since the Machakos agreement 13 years ago. He should address the issue radically, and there is no cure except what we have always been offering and advising to implement, which is the establishment of Islam, by making the provisions of Islam into practice and implementation, by which the Islamic way of life is resumed, in the Khilafah State (Caliphate) on the method of Prophethood, which led the world and spread goodness in its lands, and solved the problems of the people and the countries, because indeed, it is bestowed out of the grace of One who is Wise, All-Aware.
